WHAT IS ELOPEMENT

ELOPEMENT IS A FORM OF UNSUPERVISED WANDERING THAT LEADS TO THE RESIDENT LEAVING THE FACILITY. THIS ENDANGERS THE RESIDENT IMMEDIATELY AND CAN RESULT IN SERIOUS INJURY, OR EVEN DEATH.

WANDERING VS. ELOPEMENT

WHILE ELOPEMENT RESULTS IN A PATIENT LEAVING
THE FACILITY ALTOGETHER, WANDERING IS WHEN A
RESIDENT LEAVES A SAFE AREA WITHIN THE NURSING HOME OR LONG-TERM CARE FACILITY. THIS COULD
MEAN THEY WALK EXCESSIVELY OR WANDER AWAY
FROM THEIR ROOM OR A SPECIFIC FLOOR.

WHY DO RESIDENTS WANDER?

UNFAMILIAR ENVIRONMENT CHANGES IN MEDICATION BEING OVERLY MEDICATED UNMET PHYSICAL NEEDS ALZHEIMER'S DISEASE

UNMET EMOTIONAL NEEDS CONFUSION DEMENTIA

TYPES OF WANDERING

AIMLESS WANDERING IS WHEN THERE'S NO PURPOSE BEHIND IT.
THIS COULD BE DUE TO BOREDOM, STRESS, BEING UNCOMFORTABLE, OR CONFUSION

AGITATED WANDERING SOME RESIDENTS MAY WANDER BECAUSE THEY ARE AGITATED, ANXIOUS, OR UNDER STRESS.

RESPONSIVE WANDERING RESIDENTS MAY BE RESPONDING TO A SPECIFIC NEED, SUCH AS SEARCHING FOR A RESTROOM OR FOOD. RESPONSIVE OR PURPOSEFUL WONDERING HAS INTENT BEHIND IT. A RESIDENT MAY BE TRYING TO FIND A NURSE OR RETURN HOME TO THEIR LOVED ONES.

STATISTICS

PRO PUBLICA GATHERED DATA OF 118,000 DEFICIENCIES FOUND DURING GOVERNMENT INSPECTIONS AT 14,565 NURSING HOMES NATIONWIDE. IN GEORGIA, ACCORDING TO THE DATA, THERE WERE 51 ELOPEMENT DEFENCIENCIES IN GEORGIA NURSING HOMES IN 2017. THE NUMBER AND SEVERITY OF DEFICIENCIES SHOWN RELATE ONLY TO THE SEARCH TERMS, NOT NECESSARILY ALL DEFICIENCIES AGAINST THE HOME.
